Please open a Depository account (BO Account) in my/our names(s) on the terms and conditions set out below. In Consideration of **TOTAL COMMUNICATION LTD.** the "CDBL Participant" opening the account providing depository account facilities to me/us, I/we have signed the **BO Account Opening Form** as a to ken acceptance of the terms and conditions set out below.

1. I/we agree to be bound by The Depositories Act, 1999, Depositories Regulations, 2000, The Depository (User) Regulations 2003, and abide by the Bye Laws and Operating Instructions issued From time to time by **CDBL**.
2. **CDBL** shall allocate a unique identification number to me/us (Account Holder **BO ID**) for the **CDBL** Participant to maintain a separate Account for me/us, unless I/we instruct the **CDBL** Participant to keep the securities in an Omnibus Account of the **CDBL** Participant.
